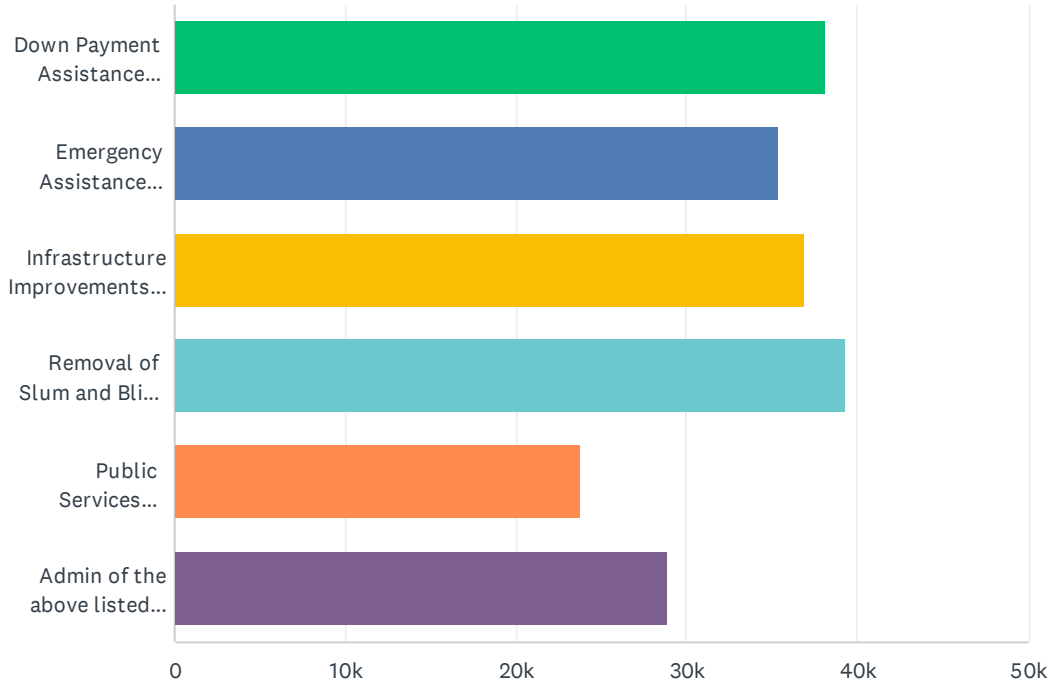


Q1 If you were budgeting \$268,051 between the listed programs, how would you allocate the funds?

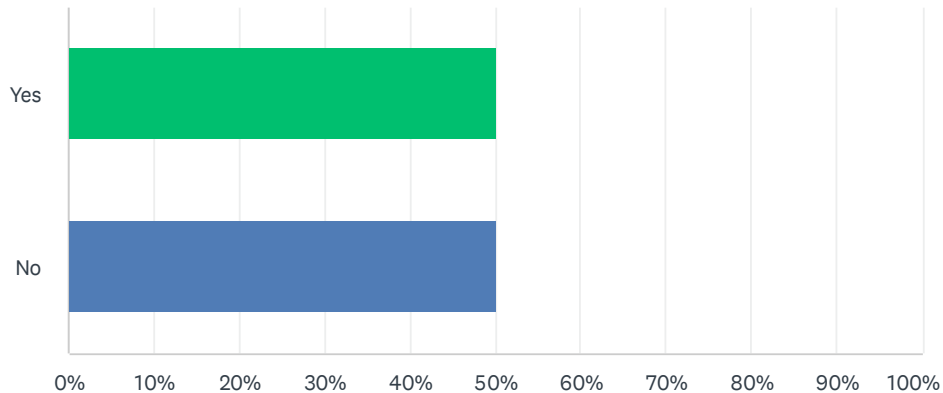

1	The high number of derelict buildings invites crime. When I go to the library, there are usually homeless men hanging around outside, using extremely vulgar language and smoking what look like marijuana joints. People have told me of sex trafficking there--men approaching homeless women to offer them overnight housing in exchange for sex. I've also been told of a young women who was walking home from the library being accosted by a homeless man. People who can't get a bed at the Salvation Army because they're high on drugs and engaging in threatening and other criminal activity shouldn't find a safe haven at the library where there are no social workers and staff are not equipped to deal with their serious issues. Also, when the house next to my children's preschool caught fire, I heard it was started by homeless men who lit a fire in the middle of the living room--and the burned out building is still standing. I appreciate the efforts the city has taken recently, and I think the situation is improving, but I think having so many tornado-damaged and blighted properties in these low-income areas is the most negative influence in this area, and it causes other good public facilities (like parks and libraries) to become negative.	4/16/2023 4:05 PM
